Household use of green cleaning products, disinfecting wipes and asthma control among adults

Highlights Box

What is already known about this topic?

Household use of cleaning products may negatively impact asthma control, but few studies have examined these associations and none evaluated the impact of green ones or those used in wipe form, both increasingly used.

What does this article add to our knowledge?

An almost daily use (4-7 days/week) of household cleaning products, including green ones or those used in wipe form, was associated with 2- to 3-fold increased risk of uncontrolled asthma.

How does this study impact current management guidelines?

We suggest health practitioners to consider the household use of cleaning products and advise their patients to limit as possible their use of products in order to improve and maintain asthma control.

Background: The use of Household Disinfectants and Cleaning Products (HDCPs) may
negatively impact asthma control, but studies remain scarce. Moreover, none considered
green products or wipes, increasingly used during home cleaning.

Objective: To assess the associations between the use of HDCPs, including disinfecting wipes
and green products, and asthma control based on data from the French web-based NutriNetSanté cohort.

Methods: Using a standardized questionnaire (2018), we assessed asthma control (never asthma - reference, controlled: ACT≥20, uncontrolled: ACT<20) and the use of HDCPs, including two types of products (irritants and green products) and two application modes (sprays and disinfecting wipes). Cross-sectional associations of the frequency of weekly use of HDCPs at home with asthma control, adjusted for gender, age, smoking status, body mass index and educational level were assessed by multinomial logistic regressions.</p>

Results: Analyses were performed on 37,043 adults (mean age: 47 years, 75% women, 62% with a weekly use of at least one HDCP). Strong associations were observed between weekly use of HDCPs and uncontrolled asthma. In particular, an almost daily use (4-7 days a week) of irritants (OR=2.81[1.97-4.00]), green products (OR=2.40[1.70-3.39]), as well as sprays (OR=2.69[1.97-3.68]) and disinfecting wipes (OR=3.51[2.31-5.33]) was associated with uncontrolled asthma. When not co-used with irritants and sprays, associations remained statistically significant for both disinfecting wipes and green products.

Conclusion: Weekly use of HDCPs, including green ones or wipes, was associated with
uncontrolled asthma and should be considered by health practitioners in order to improve
asthma control.

1 Introduction

2

3 As thma is a major public health issue due to the global burden and costs it generates (1-3). 4 There are about 300 million people who have ever suffered from asthma worldwide (4), 5 making asthma one of the most common reported chronic diseases in the world (2,5). To date, 6 no treatment has been able to fully heal asthmatic patients (2). The main objectives of 7 international recommendations for asthma management are to control symptoms and to 8 prevent future risk of exacerbation and persistent airflow limitation, while minimizing the 9 side effects of asthma treatment(s) (6). Achieving optimal asthma control remains a challenge 10 (7). Indeed, observational studies showed a suboptimal control for the majority of asthmatic 11 patients (3,8), regardless of disease severity (3), and with even higher proportions of 12 uncontrolled asthma among women (9). The level of control may vary over time (3) and a 13 deterioration in the control of the disease is followed by a deterioration in the quality of life 14 (3,7,8). Indeed, the intensification of symptoms is linked to an airflow limitation, which leads 15 to difficulties in performing certain daily activities and can have significant repercussions on 16 social and professional life (3,7,8). Beyond the treatment of asthma, health practitioners 17 should also focus on the identification of modifiable behavioral and environmental factors (7), which could improve and help maintain asthma control (2,5,10). 18

20 The risk factors for poor asthma control are multiple (3), with factors related both to 21 individual characteristics of the patient (e.g. poor adherence to asthma treatment or an 22 incorrect use, comorbidities) or environmental triggers (3,10). Among the latter, a few 23 epidemiological studies have suggested an adverse impact of exposure to cleaning products, 24 both at work (11–14) and at home (15,16), on asthma control in adults, especially among 25 women. Specifically, in two French cohorts, both ever (11) and current (past 12 months) (12) occupational exposure to cleaning products was associated with uncontrolled asthma. In the 26 27 European Community Respiratory Health Survey (ECRHS), the attributable risk of 28 uncontrolled asthma for current occupational exposure to cleaning products was estimated at 29 about 9% and higher associations were observed for occupational long-term exposure to 30 asthmagens (13). Finally, the use of disinfectants by U.S. nurses in the workplace was 31 associated with uncontrolled asthma (14).

Regarding the use of Household Disinfectants and Cleaning Products (HDCPs), only two epidemiological studies, both carried only in women, assessed the adverse effect of the household use of some categories of cleaning products on asthma control (15,16). These two
studies provided evidence of an association of a weekly use at home of sprays (15,16) and
irritant HDCPs (16) with poor asthma control.

38

39 Several cleaning products, of various composition and application modes, can be used to 40 complete different household tasks (17). Since the respiratory risks associated with the 41 household use of irritants or sprays are increasingly well documented (18), consumers might 42 choose alternatives to these products, such as using green products and wipes (instead of 43 sprays). However, the associations between the household use of such alternatives and asthma were assessed by only one epidemiological study based on adults from the CONSTANCES 44 45 cohort (19). Results suggested that the use at home of green products might induce fewer risks for respiratory health, whereas using disinfecting wipes could induce a higher risk of asthma 46 47 symptoms (19). Nonetheless, to what extent these newly-studied products could affect asthma control is unknown. 48

Our main objective was to assess the associations of irritants, sprays and two common
newly-studied products (disinfecting wipes and green products) with asthma control among a
large and mixed gender population of French adults from the NutriNet-Santé cohort.

53 Methods

55 Population

56

57 The NutriNet-Santé study is an ongoing web-based prospective cohort initiated in 2009 with 58 the objective to study the relationships between nutrition and chronic diseases, aging and 59 quality of life, and the role of different determinants on eating behaviors and health status (20). Participants aged over 18 with access to the Internet were recruited from the general 60 61 population through a vast multimedia campaign (television, radio, newspapers and the 62 internet) and relayed in particular by health professionals. Information on respiratory health 63 (in 2016, 2017 and 2018) and the use of HDCPs (in 2018) was collected by self-administered 64 standardized questionnaires completed on the study website (https://etude-nutrinet-sante.fr). Electronic informed consent is provided by each individual included in the NutriNet-Santé 65

cohort. The study is registered at <u>https://clinicaltrials.gov/ct2/show/NCT03335644</u>, conducted
according to the Declaration of Helsinki guidelines and approved by the Institutional Review
Board of the French Institute for Health and Medical Research (IRB-Inserm) and the
"Commission Nationale de l'Informatique et des Libertés" (CNIL n°908450/n°909216).

71 Use of HDCPs and co-use of irritants/sprays

72

We studied the use of HDCPs in the last 12 months, including two types of products: irritants (bleach, ammonia, acids and solvents) and green products (How many days per week did you personally use "organic" or "green" cleaning products?), and two application modes: sprays (furniture, glass, floor, bath, oven, ironing, air freshener, insecticide, or other use) and disinfecting wipes (cleaning and disinfecting wipes), as previously defined in the CONSTANCES cohort (19).

The frequency of weekly use of these products was reported in four classes (never, less than one day a week, 1-3 days a week, 4-7 days a week). For each category of products, we used the highest frequency reported among all products from the category. As commonly done, "never" and "less than one day a week" were grouped together to define the group with a "no weekly use" (15,21). For a given cleaning product, participants classified as "no weekly use" but who reported a weekly use of at least one of the other products studied (irritants, green products, sprays or disinfecting wipes) were excluded from the analyses. Thus, the reference group (no weekly use of any of the four products studied) was the same in all analyses (16,19). Frequency of use was studied with a 3-class variable (reference, 1-3 days a week, 4-7 days a week) in the main analyses and with a binary variable (reference, ≥ 1 day a week) in stratified analyses. The number of products used weekly was also calculated for irritants and sprays and was studied with a 3-class variable (reference, 1 product, ≥ 2 products).

We studied the co-use of disinfecting wipes and green products with irritants and/or sprays (established asthma risk factors) with a 3-class variable (reference, product not co-used with irritants and sprays, product co-used with irritants and/or sprays), as previously done when considering newly-studied products (19).

98 Current asthma and asthma control

99

100 Participants who answered positively to the following question "have you ever had attacks 101 of shortness of breath at rest with wheezing or asthma attacks?" in 2016, 2017 or 2018 were 102 classified as "ever asthma", and otherwise as "never asthma". Among participants with ever 103 asthma, those who reported at least one asthma symptom or asthma attacks or an asthma 104 treatment in the last 12 months in the 2018 questionnaire were considered to have current 105 asthma. Participants with asthma in remission (ever asthma but no current asthma) were 106 excluded from analyses (Figure E1) since we studied current (last 12 months) household use 107 of cleaning products.

Asthma control was assessed by the Asthma Control Test (ACT), a clinically validated measure of asthma control (22–24). The ACT score, ranging from 5 (uncontrolled asthma) to 25 (perfectly controlled asthma), was calculated by summing the answers to five questions related to the manifestation of the disease (asthma symptoms, limits in performing daily activities, use of rescue treatment, self-rate of asthma control) in the past four weeks (22,23). We studied asthma control in the whole study population by a 3-class variable (never asthma reference, controlled: ACT≥20, uncontrolled: ACT<20).</p>

117 Statistical analyses

118

In a first step, associations between the use of HDCPs and current asthma were assessed bylogistic regression models, in order to study the consistency of our results with those

previously observed in the CONSTANCES cohort (19). In a second step, associations 121 122 between the use of HDCPs and asthma control were assessed by multinomial logistic regression models. Analyses were adjusted for gender (men, women), age (continuous), 123 smoking status (never smoker, ex-smoker, current smoker), Body Mass Index (BMI - <24.9, 124 25-29.9, \geq 30 kg/m²) and educational level (<high school diploma, high school to 1-year post-125 126 secondary, 2-3 years post-secondary, >3 years post-secondary), potential confounding factors 127 chosen based on a review of the scientific literature on this research topic. As a sensitivity analysis, we repeated the main analyses after exclusion of participants with self-reported 128 occupational exposure to cleaning products. To evaluate the robustness of the results, analyses 129 were stratified by gender, age (<45 years, \geq 45 years), smoking status, BMI (<25 kg/m², \geq 25 130 kg/m²), educational level (\leq 1-year post-secondary, >1-year post-secondary) and household 131 help (yes/no according to the question "Are you getting help to do home cleaning, e.g., 132 husband, household employee, family members, friends, ...?) and we calculated interaction 133 134 tests. Finally, we also assessed associations with asthma control only among participants with 135 current asthma by a 2-class variable (controlled - reference, uncontrolled) (16).

The analyses were performed using the statistical analysis software SAS version 9.4 (SAS
Institute, Cary, NC, USA). The associations were considered statistically significant if the pvalue was lower or equal to 0.05 and borderline significant if p-value≤0.10. We calculated
odds ratios (ORs) with 95% confidence intervals (CIs).

140 Results

141

The analyses related to current asthma were based on 37,043 participants with no missing data on household exposures to cleaning products and asthma status in 2018, including 2,609 participants with current asthma (Figure E1). The analyses related to asthma control were performed on 36,623 participants, including 1,669 participants with controlled asthma and 490 with uncontrolled asthma (Table 1).

147

Participants were 47 years old on average, 75% were women, 12% were current smokers, 32% were overweight (BMI \geq 25 kg/m²) and 63% had at least a 2-year university educational level (Table E1). Compared to participants excluded due to missing/inconsistent data for household exposures and asthma status (n=987), included participants were less often current smokers (12.5% *versus* 14.6%; p=0.004) and overweight (32.2% *vs.* 36.4%; p=0.005; Table E1).

154

Participants with current asthma were younger, and more often women, current smokers, overweight and with a higher educational level than participants without asthma. They reported a higher weekly use of HDCPs, whatever the type or form of cleaning products (Table 1). Uncontrolled asthma was more frequent among older participants, women, current smokers, overweight participants, those with a lower educational level and among those who reported a higher weekly use of each of the four cleaning products studied.

162 Use of HDCPs and current asthma

163

164 Weekly use of HDCPs was positively associated with current asthma (Table 2), regardless of the products used (ORs_{irritants}=1.25[1.12-1.40] and 1.69[1.42-2.01], ORs_{spravs}=1.18[1.05-165 166 1.33] and 1.52[1.31-1.77], ORs_{disinfecting wipes}=1.46[1.26-1.68] and 1.89[1.51-2.37], ORs_{green} 167 products=1.25[1.12-1.41] and 1.48[1.25-1.75]; for a use 1-3 and 4-7 days/week, respectively), 168 with a dose-response trend according to the frequency of use (all p-trends are statistically 169 significant). A dose-response trend was also observed for the number of irritants and sprays 170 used (Figure E2). These associations remained statistically significant after exclusion of 171 participants with potential occupational exposure to cleaning products (Table E2; ORs 172 ranging from 1.2 to 1.5 for 1-3 days/week and from 1.5 to 1.9 for 4-7 days/week). In addition, 173 most associations between weekly use of HDCPs and current asthma were of similar

magnitude after stratification by gender, age, smoking status and educational level (Table E3), with non-significant interaction tests (p-interaction>0.15). However, associations with irritants, sprays and green products were stronger in overweight participants (pinteraction<0.05), compared with participants with a BMI lower than 25 kg/m² and in participants without household help (p-interaction<0.05), compared with those with household help.

In the absence of co-use of irritants/sprays (Figure 1), the weekly use of disinfecting wipes
(OR=1.42[1.14-1.78]) and green products (OR=1.19[1.02-1.38]) remained positively
associated with current asthma.

184 Use of HDCPs and asthma control

186 Weekly use of each of the HDCPs studied was positively associated with controlled and uncontrolled asthma (ORs_{irritants}=1.65[1.27-2.14] and 2.81[1.97-4.00], ORs_{sprays}=1.49[1.13-187 1.97] and 2.69[1.97-3.68], ORs_{disinfecting wipes}=2.20[1.61-3.01] and 3.51[2.31-5.33], ORs_{green} 188 189 products=1.49[1.13-1.96] and 2.40[1.70-3.39]; for a use 1-3 and 4-7 days/week, respectively), 190 with a dose-response trend according to the frequency (Table 3) and the number of products 191 used (Figure E3). In particular, we observed strong associations (ORs ranging from 2.4 and 192 3.5) between an almost daily use (4-7 days/week) of each of the HDCPs studied and 193 uncontrolled asthma, whereas modest associations (ORs<1.5) were observed for controlled 194 asthma, compared to participants without asthma. These associations remained statistically 195 significant after exclusion of participants with potential occupational exposure to cleaning 196 products (Table E4; 4-7 days/week: ORs ranging from 1.3 to 1.5 for controlled asthma and 197 from 2.4 to 3.4 for uncontrolled asthma). In addition, most associations were of similar 198 magnitude after stratification by gender and household help (Table E5, p-interaction>0.15), as 199 previously observed for current asthma. However, associations with irritants, sprays and green 200 products were stronger in younger participants (<45 years; p-interaction<0.1), compared with older participants (\geq 45 years), and in overweight participants (p-interaction<0.1), compared 201 with participants with a BMI lower than 25 kg/m^2 (Table E5). 202

203 When not co-used with irritants and sprays, associations remained statistically significant for

disinfecting wipes (OR=1.99[1.24-3.22]) and green products (OR=1.59[1.12-2.23]) only with

205 uncontrolled asthma (Figure 2).

When considering participants with controlled asthma as reference only in participants withcurrent asthma (Table E6), ORs were generally lower than when considering never asthma as

- 208 reference in the whole study population, but associations with uncontrolled asthma remained
- 209 mostly statistically significant with ORs>1.9 for all products used almost daily.

210 Discussion

211

Weekly use of irritants, sprays and two common newly-studied products, i.e., disinfecting wipes and green products, was strongly associated with uncontrolled asthma. For an almost daily use of HDCPs, we observed 2- to 3-fold increased risk of uncontrolled asthma. When not co-used at home with irritants and sprays, disinfecting wipes and green products remained associated with uncontrolled asthma.

217

218 Results related to current asthma were consistent with previous epidemiological studies 219 assessing the adverse effect of household use of irritants (19,25-27) and sprayed 220 (15,19,27,28) cleaning products and we observed a dose-response trend for the frequency and 221 number of irritants and sprays used. We also evidenced a dose-response trend for the 222 frequency of use of disinfecting wipes, green products and current asthma, as recently found 223 in the French CONSTANCES cohort (19), but with stronger associations in the NutriNet-224 Santé survey. However, after considering the co-use of irritants/sprays at home, results partly 225 differed from those obtained in CONSTANCES (19). Indeed, in the current study, the 226 associations persisted for both disinfecting wipes and green products; in contrast, in the 227 CONSTANCES cohort, the association persisted for disinfecting wipes but disappeared for 228 green products. This difference between the two studies does not seem to be attributed to the 229 frequency of weekly use of cleaning products, as the same percentage of participants use 230 green products weekly (31%)/almost daily (7%) in both NutriNet-Santé and CONSTANCES. 231 This difference might be partly explained by the fact that there are more women in the 232 NutriNet-Santé cohort than in the CONSTANCES cohort. In addition, we do not exclude the 233 fact that participants of NutriNet-Santé do not use the same green products as those of 234 CONSTANCES as we could not verify which products participants considered as green ones. 235 In order to better identify the reason for this difference in results, it would be important to 236 know the composition of green products used by participants of the two cohorts.

Regarding asthma control, to our knowledge, our study is the first one investigating associations of disinfecting wipes and green products with asthma control. Results obtained regarding the weekly use of irritants and sprays with uncontrolled asthma corroborated those from the two previous epidemiological studies on the topic (15,16). We also observed statistically significant associations for the weekly use of disinfecting wipes and green 243 products with uncontrolled asthma. Associations were stronger for an almost daily use of each 244 product studied and for uncontrolled asthma. Therefore, a frequent use of HDCPs can affect asthma control, regardless of their type or application mode. Associations persisted for a 245 246 weekly use of disinfecting wipes and green products only with uncontrolled asthma when not 247 co-used with irritants and sprays, which indicates that their use alone also implies a higher 248 risk of uncontrolled asthma. We also observed modest associations with controlled asthma, 249 probably reflecting the association between HDCPs and current asthma in general. Indeed, 250 associations with uncontrolled asthma persisted when studying them among participants with 251 current asthma. Due to lack of power, we were not able to consider the co-use of 252 irritants/sprays when newly-studied products are used almost daily.

254 One strength of using data from the web-based NutriNet-Santé cohort is the possibility to 255 assess associations on a large population, including both men and women. However, 256 participants recruited in this cohort are more often women, with a high educational level and 257 must have an internet access to complete web-questionnaires, making them not representative 258 of the French population (29). Therefore, our results cannot be generalizable. Nonetheless, as 259 previously detailed, our results are mostly consistent with those observed in other population-260 based epidemiological cohorts (EGEA, E3N, CONSTANCES, ...) for household use of 261 cleaning products (15,16,19,25,26,28). Furthermore, results are also consistent with those 262 observed in occupational exposure (11-14). Our result suggested for the first time that weekly 263 use of disinfecting wipes as well as green products may have a deleterious impact on 264 uncontrolled asthma. Another strength of our study is that we considered the co-use at home 265 of irritants and sprays, as there is more and more evidence of the adverse effects of using 266 these products (15,16,21,25–28,30,31) and as it is more probable that disinfecting wipes and 267 green products are used with irritants/sprays. Without studying this co-use, associations could 268 have been overestimated. When considering this co-use, results persisted only with 269 uncontrolled asthma, strengthening our results evidencing the deleterious role of disinfecting 270 wipes and green products in asthma control. Furthermore, the results were similar after 271 considering the additional co-use of green products or wipes (results not shown). Another 272 strength of our study is the evaluation of asthma control by the ACT, a reliable method to 273 assess this outcome (22-24). After exclusion of participants with potential occupational 274 exposures to cleaning products, associations remained of similar magnitude both for current 275 asthma and asthma control. Finally, our results are robust because most statistically 276 significant associations persisted after the stratifications performed.

The main limitation of our study relies on the assessment of exposure to HDCPs by self-278 279 report through a questionnaire. This method could induce differential misclassification error 280 as asthmatics may tend to pay more attention to their symptoms when using a cleaning 281 product. However, the main objective of the NutriNet-Santé study was not to investigate the 282 respiratory health determinants, such as indoor air pollution and the household use of cleaning 283 products. Therefore, participants' answers are not likely to be influenced by the objective of the present analysis. In addition, some questions regarding for example the use at home of 284 285 green products may lack of clarity and specificity if participants are not familiar with these products, which could induce a non-differential misclassification error. Moreover, by 286 287 questionnaire, it is not possible to collect information on the composition of the HDCPs 288 evaluated, which makes impossible to conclude on the compounds involved. In order to 289 answer this question, it would be necessary to use new methods of assessment of exposure to 290 household cleaning products, as the one used in the SEPAGES cohort (Barcode-Based 291 Smartphone Application subsequently linked with an ingredients database) (27). In contrast to 292 the CONSTANCES study (19), we could not evaluate in NutriNet-Santé the impact of using 293 homemade cleaning products on asthma and its control as this question was not in the 2018 294 questionnaire. Due to the cross-sectional design of our study, as asthma and household 295 exposure to HDCPs were estimated at the same survey (2018), it is not possible to conclude 296 on causality. In addition, we do not exclude a possible reverse causation mechanism due to 297 the fact that some participants with current asthma might use more frequently HDCPs 298 intending to eliminate some household exposures they believe causing their symptoms (i.e. 299 dirt, dust, allergens, molds, etc.). Nonetheless, considering the consistency of our results with 300 those of previous epidemiological studies on occupational exposure to cleaning products (11-301 14), where professionals cannot choose the frequency of use of these products, we do not 302 think that associations evidenced in the present study could only be attributed only to reverse 303 causation.

In conclusion, the use of HDCPs, regardless of the types of products and application modes studied, was associated with uncontrolled asthma. More precisely, our results suggested a negative impact for asthma control of disinfecting wipes and green products. Further research is needed in order to determine which compounds in green products must be avoided. Therefore, our results showed the importance of considering the use of HDCPs when evaluating asthma control. In particular, health practitioners should recommend their patient to change their cleaning habits to reduce the weekly use of HDCPs, in order to improve and
maintain asthma control. As asthma control is known to vary over time, longitudinal studies
are needed to examine precisely the long-term effects of the household use of cleaning
products on asthma control.

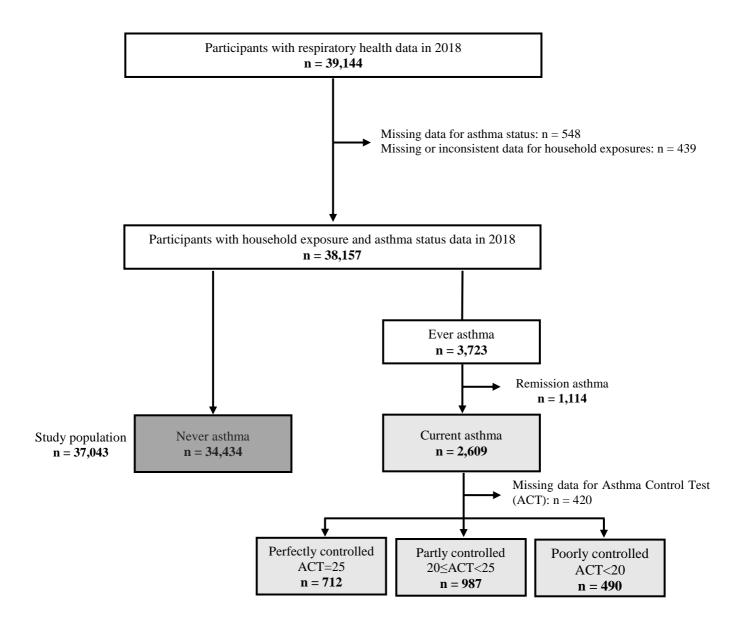


Figure E1. Flowchart of the study population
